1.2 Checking out

1.3 Preceptive authority

Please follow the instructions of your A-T-K Fryšták s.r.o. guide. Please pay attention to the forbidden commands and warning notices inside the premises. Disobedience may lead to an immediate expelling from the premises. In case of injury, please inform your A-T-K Fryšták s.r.o. guide.

1.4 Smoking/alcoholic beverages



Smoking is allowed only in designated areas and during a set time. In case of need, please ask your guide and you will be provi-ded with a plan of the premises with marked smoking areas. Sale and

consumption of tobacco, alcohol and other narcotics is prohibited.

1.5 The prohibitting of recording



Filming or any other kind of audiovisual recording is strictly forbidden. Please note that the premises are under camera surveillance at all times.

2. TRAFFIC RULES



General traffic rules apply on the premises. The maximum speed is limited to 15km/h. Cars must be parked in the spaces signed "P – A-T-K". Please stay on the car roadways and drive through
